

Timeline for the Residential Tenancies Act (RTA) Review – updated as at 16.10.18

The following timeline excludes the time invested on the work carried out between meetings and each RTA deadline. Email communication, review and feedback on all written submissions and telephone discussions has been abundant.

1. REINSW Formed a dedicated Sub-Committee to address the RTA 2010 back in June 2015 with the first teleconference 17 July 2015 (in anticipation of the RTA review)

The deadline for the Submission was Friday, 17 November 2017. NSW Fair Trading provided an extension to Tuesday, 21 November 2017.
- 21. REINSW lodged their Submission responding to the six Residential Tenancies Act Review topics that were opened for further consultation Tuesday, 21 November 2017. This Submission was No 4 in response to the draft Residential Tenancies Amendment (Review) Bill 2017 (the version of the Bill dated 2 August 2017).
- 22. NSW Fair Trading on Wednesday, 29 November 2017, offered REINSW the opportunity to provide a Submission on one more additional topic that the Minister raised under the RTA Review. This topic falls under the <u>CABINET-IN-CONFIDENCE</u> condition.

The ADDENDUM responds to the additional topic that was opened for further consultation by the Minister. The Addendum was lodged Wednesday, 6 December 2017.
- 25. REINSW raised an issue with NSW Fair Trading Wednesday, 20 December 2017, requesting consideration be given to an operational issue that may be possible to address under the RTA Review. NSW Fair Trading noted this request.

- NSW Fair Trading provided the fourth draft RTA Draft Bill as <u>CABINET-IN-CONFIDENCE</u> Thursday, 12 July 2018 (12.36 pm) for written comments and/or discussion by Friday, 27 July 2018. (This allowed 11 working days to respond). REINSW requested an extension and NSW Fair Trading provided an extension to Friday, 3 August 2018.
